General Application Details:

- Surfaces must be clean, sound and stable. Further, surfaces must be free of loose foreign material, existing coatings, laitance, release agents, curing compounds and oil/grease residue.
- Aus-Bond Ultra Prime should be lightly stirred before using, and can be applied to vertical, horizontal and overhead surfaces using a roller, brush or airless spray unit.
- Coverage of 12m²/L, this may vary depending on surface porosity.
- Not suitable for solvent based finishes. Only use water based systems over **Aus-Bond Ultra Prime**.
- Can be rendered or tiled over.

Important Notes:

- Not designed for use as an exposed or trafficable sealer.
- Not to be used for applications in immersed areas.
- Based on normal ambient conditions of 23°C, drying times are:
 - Tack free 15 minutes (will vary with surface porosity),
 - Dry film 30 minutes.
- •Best storage conditions are in a dry area at room temperature. Avoid humidity and frost.
- While in a wet state, **Aus-Bond Ultra Prime** will clean up with water. Once dried product will need to be removed by clean (or soapy) high pressure solutions.
